Wow, a nice example! The engraving details are very crisp!

Here's my shot at dating it with case #s. The case was likely made mid/late 1925 and I believe is actually an unsigned Wadsworth case. Many of the Ultra Quality line, including these and the tanks, remained unsigned long after gf/reinforced cases started being signed, but they follow wads case #s, including the jump to 5mm in late 1925/early 1926. This case was made either just prior to that jump or maybe even concurrent: it appears Gruen built up a large stock of GF Quadrans right at the 5mm jump, occupying much of 5-5.1mm.

I believe the movement may be later, perhaps 1927. Can't tell for sure, but from the font your sn looks like it could be 151k vs 161k. The 179 examples I have for this time indicate mvmt #s 118k @ UQ case # 995k, 129k @ 1028k, 138k @ 5108k, 148k @ 5110k. Mid-1928, 179 was @ 173k.

Looking forward to hearing what others have to say.

The 179s have a strange numbering scheme. I own six of them with the following case /serial / maker combinations:

125686 / 996799 / GRUEN ULTRA QUALITY
130365 / 5144168 / Wadsworth 14K GOLD REINFORCED WITH METAL
320132 / 5158901 / Wadsworth 14K GOLD REINFORCED WITH METAL
320317 / 5239682 / Wadsworth 14K GOLD FILLED REINFORCED WITH EXTRA GOLD
320411 / 5278253 / Wadsworth 14K GOLD FILLED REINFORCED WITH EXTRA GOLD
1216071 / 2112798 / GRUEN 14K GOLD FILLED REINFORCED WITH EXTRA GOLD

The first one I dated the case probably too early, but I gave it a 1922 for the case and 1926 for the

movement.

Number two and three I gave a 1926 for the case and a 1927 for the movement.

Number four and five got a 1927 all over.

The last one got a 1931 for the case and a 1930 for the movement.

The three 320k movements are very close, but three different watches: Strap 28, Strap 57 and Strap 91. The 30s one is a Strap 176.

Hi Gary,

I have the exactly same case with serial 5136844, so just 2k apart from yours. Strangely mine houses a "Watch Specialties Co" marked 806 movement which other than this 1926 case, dates towards 1917 to 1920. So I think mine got a movement swap before I bought it.

I think that in 1926 Gruen was not able to fulfill the demand with their usual supply so they sourced here and there even with the cases in order to satisfy the demand. The demand on the plain version of the Ladies Paris Square might have been deminishing, so they bought a batch from Moeri and stamped it in the US.

Just one possibility.

Just curious, Gary & Barney--do both of your 5MM series UQ cases now lack the "P" stamped in front of the case # last 4 on the bezel? Looks like Gary's does not have a "P" above--there's something but unclear. Not a clear "P" in same font as +last 4, like you see on the case for Wristlet 103 and for Jack's case above.

I expect they do not have a "P", but would like confirmation. This relates to the Wadsworth case sequence(s).
